Pete Knight Rodeo Royalty Rules & Regulations

In order to be eligible to participate in the competition:

1. Pete Knight Royalty Contestants must be a female at birth, never married or living common law, pregnant, had a child or pleaded guilty to or found guilty of a criminal offence. If the queen/princess becomes pregnant, married or living common law during her reign, she will forfeit her crown and all benefits derived from the competition.
2. Pete Knight Royalty Contestants may not be currently holding any title unless they will be passing their title on before May 1st of the competition year.
3. Pete Knight Royalty Contestants must be between the ages of 14-17 years of age. She must be 14 years of age by January 1st of the competition year. Disputes regarding a contestant's age will require a certified copy of that contestant's birth certificate.
4. Maximum number of contestants – first 6 eligible entries received. Entries will be deemed received when they reach the assigned address on the enclosed.
5. Minimum number of contestants – there must be at least 3 contestants in order to run the competition. The Pete Knight Rodeo Royalty Committee and/or board reserve the right to continue or cancel the contest, combine categories due to lack of entries, or deny entry for prior misconduct at the contest.
6. There will be only 1 queen and 1 princess for the reign.
7. Contestants must be a person who has her principal place of residence within a reasonable radius of the Crossfield area. The decision of who has, and who has not, her principal place of residence in this area is solely on the Pete Knight Rodeo Royalty Committee.
8. Contestants must own a horse, or have a horse available for her during the competition and for her reign as queen/princess. Her horse must be suitable for this use and competition. Suitability will be up to the Pete Knight Rodeo Royalty Committee.
9. Contestants must use the same horse for the entire contest; a second horse must be proven suitable in the event the horse becomes sick or injured. If so, report to the Royalty Committee immediately. The Committee can also request your alternate horse to be used if any safety issues arise.
10. Pete Knight Royalty Contestants will not use foul language, consume any alcohol, smoke or partake in any drugs (legal or illegal) in public view, at the rodeo dances, on the rodeo grounds or at any function or event to which she has been invited during this contest or during her reign.
11. Contestants must attend each and every scheduled function during the months of competition and be willing to fulfill the commitments during her reign, which can include weekend and weekday appearances. School days will obviously be taken into consideration.
12. Contestants must be prompt and on time throughout this contest. Tardiness will not be tolerated.
13. It will be expected that they will dress and act in accordance with the positions that they hold. Full western attire must be worn and Western tack used.
14. Contestants must wear a felt hat during competition and upon being crowned queen or princess, must have a black felt available for the duration of their year.
15. Contestants cannot enter another rodeo queen contest while she runs for the title of Pete Knight Rodeo Royalty, unless she has cleared it with the Pete Knight Rodeo Royalty Committee as well as the other committee. Contestants may enter a maximum of three times, although if successful, the queen is only allowed one term unless approved by the Pete Knight Rodeo Royalty Committee and Pete Knight Rodeo Board. The Princess may run again, if she wishes to run for the year following her current reign, a formal application must be presented to the Pete Knight Rodeo Board.

16. Contestants, Royalty and Past Royalty must get authorization to attend any function or event while representing Pete Knight Royalty, from the Pete Knight Rodeo Royalty Committee.
17. Pete Knight Rodeo Royalty rides horseback in parades and makes countless other appearances where she is expected to ride a horse and wear an outfit coordinated by the Royalty Committee for that event.
18. Contestants are not authorized to attend any function or event without a chaperone which has been approved by the Pete Knight Rodeo Royalty Committee.
19. Unsportsmanlike conduct will NOT be tolerated. Any un-sportsmanlike conduct will result in the contestant being removed from the contest, and not allowed to compete in future Pete Knight Royalty contests. Any prizes/accoutrements that have been won will be forfeited and returned in the same condition they were received.
20. Pete Knight Rodeo weekend is mandatory for all performances, Parade, Breakfasts, etc.
21. Parental interference is not permitted. Formal complaint in writing would need to be addressed to: Pete Knight Rodeo Royalty Committee.
22. Keep in mind that other people over hear your conversations in public. Statements you make may be noticed more and/or have more impact than those made by the general public.
23. In the event of the Pete Knight Royalty Queen/Princess fails to complete her reign, it is hereby understood and agreed that she will return the crown, the prizes and/or gifts received at any time during her reign, as requested by the Pete Knight Royalty Committee.
24. The Pete Knight Royalty Committee may revoke the title of Pete Knight Royalty Queen or Princess if any one of the following conditions exist:
 - a. severe illness or disability of any kind whatsoever;
 - b. failure to behave in a manner befitting the title in accordance with the standards set by the Pete Knight Rodeo Royalty Committee;
 - c. a disinterest in the fulfilling of her duties;
 - d. any breach of this agreement.
25. The Pete Knight Royalty Committee must approve all engagements.
26. "ALL JUDGES DECISIONS ARE FINAL"

FCA Rodeos such as; Water Valley Stampede, Pete Knight Days, Dog Pound Stampede, Didsbury Rodeo, Cochrane Lions Rodeo and FCA Finals may be considered as part of our mandatory engagements. Along with Pro Rodeos such as; Sundre Pro Rodeo, Airdrie Pro Rodeo, Medicine Hat Stampede, and Strathmore Stampede.

Town events such as farmers markets, Pumpkin Hunt, and Christmas Market may also be considered mandatory.

Other events may include: Local 4-H engagements, the Miss Rodeo Canada Competition, Airdrie Santa Claus Parade and more.

A formal list of events and date will be provided at our first meeting in March.

Waiver of Liability

The Participant is specifically signing this waiver in consideration of and to induce the Contest Organizers, and the Crossfield Rodeo Association and their employees, associates, volunteers and contractors (hereinafter collectively referred to as the "Releasees") to participate in the events and activities in the Contest and the Participant does HEREBY REMISE, RELEASE AND FOREVER DISCHARGE the Releasees, of and from any and all manner of actions, causes of action, claims or demands, (on account of any injury, including but not limited to personal injury, death or damage to property, the negligence or gross negligence of any party) which, the Participant ever had, now have or can, shall or may hereafter have for any cause, matter of thing, whatsoever and without limiting the generality of the foregoing with respect to their use, attendance, participation or being at the Contest and that the Participants use, attendance, participation or being at the Contest is entirely at their own risk.
