In consideration of being able to enter the Parade they accept that there accept those risks and if at anytime they find something unsafe they will Parade.	•

The Participant is specifically signing this waiver in consideration of and to induce the Town of Crossfield, the Crossfield Rodeo Association and their employees, associates, volunteers and contractors (hereinafter collectively referred to as the "Releases") to attend and/or to enter and/or to use and/or participate and/or do anything, in any event or activity at the Parade and the Participant does HEREBY REMISE, RELEASE AND FOREVER DISCHARGE the Releases, of and from any and all manner of actions, causes of action, claims or demands, (on account of any injury, including but not limited to personal injury, Death or damage to property, the negligence or gross negligence of any party) which, the Participant ever had, now have, or can, shall, or may hereafter have for any cause, matter or thing, whatsoever and without limiting the generality of the foregoing with respect to their use, attendance, participation or being at the Parade is entirely at their own risk.

The Participant fully understands that they are participating at the Parade and using the equipment on the Parade at completely their own risk and that they are aware of the hazards they can encounter while using the Parade and related equipment and that if they are driving they have a valid drivers license and that they will operate the vehicle in a safe and orderly manner.

The parents/guardians will fully instruct the minor of all of the terms of this waiver and agrees that they will not let their minor enter the Parade without a full understanding of this waiver.

The parents/guardians who execute this Waiver on behalf of a minor acknowledge and agree that should a claim be made against any of the Releases the parents/guardians will reimburse and indemnify and save harmless the Releases and their insurance company for any money or costs that they may incur as a result of such claim and I have read and understand parents/guardians acknowledge that their minors participation and/or use of the Parade and related equipment is adequate consideration for this indemnification and waiver.

The Participant understands and acknowledges that there are risks and dangers associated

in attending, being a spectator, and/or participating in the Parade and events and activities both foreseen and unforeseen which could result in, but not limited to, physical injury, total or partial disability, paralysis, death, or property damage and that the risks and dangers could be severe and that these risks and dangers could be caused by the negligence, gross negligence, action or inaction of the Participants, Spectators, Organizers or anyone at or connected to the Parade.

The Participant acknowledges that nobody has made any representation about the maintenance, reliability or safety of the Parade and related equipment or about anything whatsoever concerning their use or participation in the Parade.

The terms hereof shall be binding on the undersigned and their heirs executors and assigns and this waiver shall be a complete bar and an absolute defense to any claims made by the undersigned.

I have read and understood the above Waiver and I understand that I am giving up substantial rights by signing this Waiver and I sign it voluntarily without inducements and I assume all risks and dangers.
